2021 & 2022 MCKINLEY COUNTY PROPERTY TAXES

McKinley County Treasurer, Charles Long, is offering property owners the following options for the 2021 and the following property tax years:

E-BILLING

Are you interested in receiving your tax bills electronically by e-mail?

2015 Legislative Session, House Bill 49 was passed and allows county treasurers in New Mexico to send tax bills via e-mail. You may now choose to receive your tax bill either by paper in the mail or electronically by e-mail.

All you need to do is:

- ▲ Go online to: <https://eagleweb.co.mckinley.nm.us/treasurer/treasurerweb/search.jsp> (Use Public Login)
- ▲ Enter your Account Number and click "Search"
- ▲ Click "Verify My E-mail" and enter the Verification Code that is on your 2021 Tax Bill.
- ▲ Enter your e-mail and click "Verify Email"

PREPAYMENTS FOR THE 2022 PROPERTY TAXES

Are you interested in paying your taxes monthly in smaller amounts than 2 lump sums for next year's property taxes?

2008 Senate Bill 177, authorized county government to provide their property tax payers the option of making prepayments on their property taxes. This allows you to pay 10 monthly installments beginning June 1, 2022 and ends March 1, 2023. The first nine installments shall each be 10% of prior year's (2021) property tax bill and the final payment on March 1, 2023 shall be the balance of the tax due on the tax bill that was prepared and mailed (2022).

To be eligible:

- ▲ You must be current on your property taxes
- ▲ Your property taxes must NOT be escrowed and NOT included in your monthly mortgage payment

To Enroll: Come into our office and request to be on the program or you may go online to the web address below and fill out a request online.

We will send a **Prepayment Agreement in April 2022** that you **must sign and return**. Then we will mail you **ten payment coupons in May 2022**. Your first payment will be **June 1, 2022**.

CREDIT/DEBIT CARD PAYMENTS

McKinley County Treasurer now has an **online bill pay option** where you can pay your bill through Doxo's payment system on our website. They accept credit card, debit card and Apple Pay for a \$3.99 fee or you can use the ACH debit through your bank account for free!

Then click on the wallet icon "Pay Taxes Online", then click on "I have read the above statement", then search for your account by entering your account number in the "Account ID" field and click "Search".
