**Resolution Number JUL-25-054
A Resolution Designating the Location of Election Day Polling Places
for all Statewide Elections and Special Elections Conducted in 2026 and 2027**

WHEREAS, pursuant to the New Mexico Statutes Annotated 1978, Section 1-3-2 in June or July of each odd numbered year, the Board of County Commissioners by resolution shall designate the location of election day polling places in the County for any statewide election conducted in the calendar years 2026 and 2027; *and*

WHEREAS, the Board of County Commissioners finds that each polling place designated in this resolution complies with the provisions of NMSA 1978, Section 1-3-7, titled Polling Places; *and*

WHEREAS, the Board of County Commissioners finds this resolution along with any Early Voting locations which the County Clerk determines to maintain open on Election Day as additional Voter Convenience Centers meets the requirements of Subsections B and C of NMSA 1978, Section 1-3-4 and will be available to voters of any precinct in the county to cast a vote at a Voting Convenience Center; *and*

WHEREAS, the Board of County Commissioners finds that the polling places provide individuals with physical mobility limitations unobstructed access to at least one voting machine; *and*

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners designates the Election Day polling locations for any Statewide Election to be conducted in 2026 and 2027 be and is hereby amended as follows:

VOTER Convenience Center:

(All voters in the county may vote at these locations, regardless of where they live.)

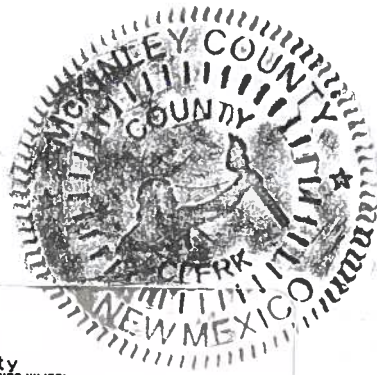
