

REGULAR LOCAL ELECTION PROCLAMATION

Pursuant to the Regular Local Election Act, NMSA 1978, Sections 1-22-2 to 1-22-19 (1969, as amended through 2019), I, Jacqueline K. Sloan, McKinley County Clerk, of the State of New Mexico, by virtue of the authority vested in me, do hereby issue the following:

That a Regular Local Election is hereby called to be held throughout the County of McKinley, State of New Mexico, and in each precinct thereof, on the 4th day of November 2025; and

That a Regular Local Election shall be a nonpartisan election, and the names of all candidates shall be listed on the ballot with no party or slate designation; and

That a Regular Local Election shall be applicable to the following local governments: Gallup of Gallup, Gallup McKinley County School District, Zuni Public School District, University of New Mexico-Gallup, McKinley Soil and Water Conservation, District, Ramah Water and Sanitation District, Yahtahey Water and Sanitation District, and Cuba Soil and Water Conservation; and

That a Regular Local Election shall be held for the purpose of permitting all qualified electors to nominate candidates for the following offices:

TO BE ELIGIBLE TO VOTE IN THE UPCOMING Regular Local Election, a qualified elector needed to be registered by October 7, 2025 or a qualified elector may register to vote or update existing certificate of registration at the County Clerk's office during regular hours and days of operation beginning October 7, 2025, through November 1, 2025. A qualified elector may register to vote or update an existing certificate of registration at all Alternate Early Voting sites during regular hours and days of operation beginning October 18, 2025, through November 1, 2025. A qualified elector may also register to vote on election day, November 4, 2025, at any of the 41 McKinley County voting convenience center between 7:00am and 7:00pm.

Declarations of candidacy and nominating petitions if required shall be filed with the McKinley County Clerk on Tuesday, August 26, 2025, between the hours of 9:00 a.m. and 5:00 p.m.

Declarations of candidacy and nominating petitions if required for a person desiring to be a write-in candidate shall be filed with the McKinley County Clerk on Tuesday, September 2, 2025, between the hours of 9:00 a.m. and 5:00 p.m.
